### J-SURS IN ACTION

Certain healthcare procedures, such as a chest X-ray or a CAT scan, combine a physician component with a technical component. When the physician component is performed separately, the procedure should be identified by a Modifier 26. This is a critical identification, because the reimbursement for this physician component is 40 percent of the fee on file.

A state Medicaid agency in the southeastern U.S. recently used J-SURS to identify recipients with procedure codes 70000-90000 billed in an inpatient or outpatient setting without the Modifier 26. In a single fiscal year, the project generated significant results, enabling the recovery of nearly \$1.7 million.


